The fire started in Woodland Hills at ten forty-six a.m., and raced through the hillside in under four hours. Los Angeles Fire Department officials suspect arson. The fire hazard will continue for several days as the Santa Ana winds will reach twenty five miles per hour.

MORE TRAVEL NEWS FROM MARGARET




