

# MARGARET INVITED TO BRIEFING SESSION AT WHITE HOUSE

#### MEETING SCHEDULED FOR OCTOBER, 1995

Recently Margaret received a letter from Dr. David E. Shaw, Chairman, D.E. Shaw & Co., who is a member of President Clinton's Committee of Advisors on Science and Technology, and Chairman of the Panel on Educational Technology. The following is quoted from his letter.


"...the Panel on Education Technology is now beginning to gather information and solicit opinions from selected academic, educational and private sectors. Toward that end, I am writing you, along with a few other prominent researchers in the field, to participate in one of two small, one day briefing sessions at the White House. These briefing sessions ... are designed to educate the panel with respect to those issues you believe to be most relevant to its charge. While we are open to any input you might wish to provide, we are particularly interested in learning what evidence currently exists regarding the efficacy of various educational technologies, and how the utility and cost-effectiveness of such technologies might be assessed in the future. In addition, we would welcome any recommendations you might have as to how the federal government might stimulate the development and widespread deployment, of demonstrably effective technologies within the nation's schools and training facilities. We will be asking each participant to speak initially for about 15 minutes, with another ten minutes or so left for questions. Time will be allocated for open group discussions after the conclusion of these individual presentations."

Dr. Shaw's letter stated that he has met with President Clinton on several instances, and that the President has stated that he is very interested in personally reviewing and acting on the committee's recommendations. Dr. Shaw also has requested that Margaret prepare a written statement for distribution to the other panel members and the committee.

We congratulate Margaret for this recognition of her past accomplishments and we are confident she will make an important contribution to the future of education in our country.


