Recently we received the following letter from Aunt Eloise, along with the obituary notice and a copy of the memorial service program, as shown below. Although distance precluded our seeing each other except on rare occasions, Jimmie and I communicated by telephone frequently, and maintained a close family relationship. With the recent visit by Listy and Birdy all of our family have met and know Jimmie and Eloise through past visits. Their kindness and generosity toward all of us will be a fond memory, and although he no longer is with us we will continue to hold him in our memories. We also extend to Susan and Debbie our deepest sympathies, along with the hope that someday they and their families, and also Eloise, will be able to visit us here in San Diego. Jimmie was very proud of his family, just as we are, and we hope for a happy future for everyone.

13 February 1997

Dear Edith and Frank,


Jimmie had not been well for three months when Birdy and Listy visited us (what a wonderful day that was - we finally got to meet the TWINS), and made a special effort to entertain them. He had no appetite but no pain, just wasn't interested in food, although he would eat. The doctor put him in the hospital the following Wednesday after Birdy and Listy were here, to have some more tests run. All tests were negative and Jimmie was released from the hospital on Friday. When he got out of the car at home, he lost his balance, fell and broke his hip. We left the hospital at 6 PM and were back at 7PM. His broken hip, although quite painful, was mending well, he was walking; but his problem of no appetite and not eating continued. When the doctors decided to make the TC scan of the stomach area, the low grade lymphoma was found. Jimmie had the first of the chemotherapy treatment, and had no ill effects at first, bur then he became extremely weak, and went downhill rapidly. Wed afternoon late he lapsed into a coma and then just stopped breathing early Wednesday night. We had no idea the end was so near. Death is always a shock, and to lose someone like Jimmie is heartbreaking.

Frank, you should be very proud of your brother. There has been such an outpouring of love and compassion. During the month Jimmie was in the hospital, he received an average of over two cards per day, and the room was always filled with flowers, fruit and candy. There were over 200 people at the services, and the floral offering was unbelievable. Jimmie had the unusual gift of making friends and then caring enough to keep the friendship active, from teenagers to the aged. Many businesses were closed so that friends could attend the services. Many of our old business associates attended as well as the Mayor, and Jimmie's good friend, the former Mayor. You wouldn't believe all the food, the visits, the cards and the memorials to the Citadel, the church and the Leukemia Society. The flowers from your family, and the one from Birdy and Listy were so pretty and most appreciated. Yours was a huge basket of red double begonias and peace lily, and the other was a variety of green plants with carnations, daisies and snapdragons. Thank you for the flowers. They surely helped to ease the pain.

Needless to say my life will never be the same again. I am very grateful that I have my work. The family and friends have seen to it that I am not alone for any length of time. I have had a problem getting around to writing thank you letters.

I appreciate very much your kind invitation to visit you. I would like to take you up on your offer at a later date. It's too soon right now to see Jimmie's side of the family. Please give everyone my love, and please take good care of yourselves.

IN MEMORY

James Daniel Riel II died Wednesday, Jan. 29, 1997, at Tuomey Regional Medical Center.

Born March 21, 1915, in Cleveland, Ohio, he was a son of the late Frank James Sr. and Edna Southam Riel. He was a 1937 graduate of The Citadel. He served as a lieutenant colonel in the African and European theaters during World War II. Mr. Riel was owner of an engineering firm, Details Bi-Riel. He was a member of the Fellowship Literary Society and Shiloh United Methodist Church. He was known to all as a "character."

Survivors include his wife, Eloise Green Riel of Sumter; two daughters, Susan Riel Silverman of Rock Hill and Debbie Riel Nix of Dalzell; a brother, Dr. Frank James Riel Jr. of San Diego, Calif.; three grandchildren, Lt. Andrew James Nix of San Antonio, Texas, Scott Clinton Nix of Dalzell and Alexander James Silverman of Rock Hill; and a host of nephews and nieces.

Memorial services will be held at 3:30 p.m. Friday at Shiloh United Methodist Church, Shiloh, with the Rev. John Bauknight officiating, assisted by the Rev. Gordon Timmons.

The family will receive friends immediately following the memorial service at the church, and at other times at the home.


RUNNY NOSE DEPARTMENT
