
Bruce and Birdy on the move!!

1877 Home featured in local publication PREIBISIVS PRIZE



One of Francie's clients brought in a copy of the March issue of San Diego Home/Garden Life Style magazine because it featured a story on our old house at 1877 Lyndon Road. In addition to the photos the text gave some history on the house, which is reproduced as follows.

Designed in the Prairie style of the Craftsman, or Arts and Crafts, architectural genre, a residence built by architect/contractor Henry Harms Preibisius 90 years ago rises majestically above a deep and picturesque canyon in Mission Hills.

The Moorish curves of the brick-floored porch soften the straight lines of the front façade and echo the home's hipped rooflines.

If the exterior of this house is remarkable, the interior spaces, 17 in all, might be even more special. To the right of the foyer, with its spectacular staircase, the serenely timeless living room, runs the width of the house. Burnished gumwood used in the foyer staircase is repeated for the original fireplace mantel, ceiling box beams, paneling and trim. Built-in seating with storage lines the west and south walls of the room. The flooring is oak.

French doors are use extensively through the entry, living room and the dining room, illuminated by an original chandelier and served by a built in gumwood buffet.

Most original fixtures remain in the upstairs bedroom, as do other features, including medicine cabinet, floor and shower tile, marble doorknobs and tub/shower. The attic has been finished into a large bedroom with a pair of skylights. Canyon, city, and

ocean. Views are visible from all the rear rooms inside the house, and two wooden decks outside behind the house. The canyon slopes down dramatically. Older, possibly original, river rock terraces and retaining walls help to level and add interest to the rear yard.

First owners of note were well known San Diego lawyer Stephen ??mnell, who later became the county's district attorney, and his wife, who served as president of both the San Diego Club and the San Diego Board of Education. Other owners included Albert J. Jones, a prominent real estate broker and charter member of the San Diego Zoological Society; civic leader Evan D. Jones, owner of the Ace Parking empire, and Dr. Robert Emerson Bond, a prominent physician. The home's current owners, who wish to remain anonymous, have occupied the house three years.

The home today is known as the Connell-Preibisiius House. It is San Diego historic landmark number 595.

NOTE: The home's architect, Preibisus, also designed the landmark 11-story St. James Hotel at 830 Sixth Ave. downtown-for years the cities tallest building. The building is still in use as a Ramada Inn.

Ed's new home project in north county area nears completion

Recently we had a chance to visit Ed's latest home building project (six homes) in San Marcos. It is nearly complete, and Ed is hoping that the rain will hold off so the final tasks can be completed. We took some pictures, as shown below. The homes are very nice, and Ed has done a great job in putting them together.





Grandpa, Grandma, and Ed visit Quail Valley lot in Riverside County

Back in 1955 Grandma and Grandpa made a small investment in a building lot located in a development named Quail Valley. It is located just north of Temecula between I-15 and I-215. The original plan was to develop the area into a country club, with a golf course and club house. Unfortunately, the project failed, and the original plans were dropped. However, we paid off the loan (\$1550), and acquired title to the property. Its current value is dependent on passing the Perc Test (a test of water drainage rate), needed for a septic tank. Since the adjoining lot has failed the test, it seems unlikely that our lot would do any better. After discussions with a real estate agent, we decided to keep the property, in the feeling that eventually a sewer system will be installed. At that time, the lot will increase considerably in value. In the meantime, we will continue to pay the taxes, and wait and see what develops.
