I was invited to ride in Lance Armstrong's Tour of Hope by a Lower School parent who works for Scripps Health. For the ceremonial launch of this Tour, and 39 Scripps and Qualcomm "vip's" were to ride 30-40 yards behind Lance and the cancer-survivors' group as they began their journey across country to raise money for research. We cancer left Scripps, rode down Torrey Pines Rd. and were separated from Lance's

#### Marguerite Stein, Family friend, dies

Several of the Riel children, especially Francie, were friends of Laura Stein when they were still in school. Francie, especially, has many memories of her and Laura being driven from one school activity to another by Mrs. Stein. She was a very active and involved mother, and made a deep impression on all who were associated with her. Mrs. Stein' obituary appeared in the August 27<sup>t.</sup> 2005 issue of the Union Tribune. It is too long to reproduce in its entirety, so we have extracted several of the more interesting items in her life.

A court reporter by day, Mrs. Stein studied law at night the University of San Diego. In 1946, after attending Hunter College and a business school she enlisted in the Navy.

stationed at the Brooklyn Navy Yard, she earned certification as a Pitman shorthand reporter, a skill she applied in naval courts-martial. She was given early discharge to work as a civilian for the Department of the Army at the War Crimes Tribunal in Europe.



After the assignment in Europe, Mrs. Stein returned to New York to attend Fordham University. She married a Marine Corps officer, Alfred F. Stein, and they had five children. After they divorced, Mrs. Stein moved her family to Chula Vista and worked as a court

reporter in the San Diego Superior Court.

Mrs. Stein was the lone woman among 15 graduates in 1966 from an initial class of 47 at USD's law school.

After being admitted to the state bar she joined the District Attorney's Office. She became the first woman in three decades to be appointed deputy district attorney in San Diego County.

In 1976 she joined the Napa County counsel's office, where she worked until she retired in 1986. In Napa County she became absorbed in the study of St. Francis of Assisi, founder of the Franciscan Order. After affiliating with School Sisters of St. Francis, she earned a masters degree at Sacred Heart School of Theology in Hales Corners, Wis

After practicing law for nearly 20 years, her faith lead her down a different path. She became a nun with the Milwaukee-based School Sisters of St. Francis.

After she left the convent she studied law at St. Paul Pontifical University in Ottawa, where in 1990 she earned a second masters degree. She served as national canonist for the Secular Francisco Order before returning to San Diego in 1994 to work as a judge for the Roman Catholic Diocese.

In 2002, after the second of two heart attacks she moved to an assisted living facility, where she served as president of the residences council.

Mrs. Stein died on Wednesday, August 24<sup>th</sup> at Kaiser Permanente Hospital of complications from heart surgery. She was 80 years old.
