#### Jeff's father dies

It is with great sadness that we report that Bernard Benesch passes away in November. We have the following obituary notice, published in the Ventura County Star.



Longtime Thousand Oaks resident Bernard E. Benesch passed away on Tuesday, November 26, 2006.

Bernard was born in Chicago, Ill., on September 25, 1925. He was a Navy veteran and a graduate of the University of California, Los Angeles (UCLA). He, his wife Audrey, and their five children came to Thousand Oaks in 1962, where Bernie was the proprietor of Conejo Village Bowl. In midlife, Bernie

switched careers, joining the Equitable Life, first as an agent, then as district manager and financial planner. Upon retirement, he began teaching insurance and investment planning.

Bernie and Audrey were one of seven founding families of Temple Adat Elohim. Until his passing, he remained active in temple affairs, the brotherhood, and his havurah.

Bernie was an active bridge and poker player. He enjoyed a good game of tennis and swimming laps in the pool. He and Audrey enjoyed trips to Europe, China, and Israel. He was a lifetime Bruin. He certainly smiled at UCLA victory! Bernie is survived by his loving wife of 57 years. Audrey; daughter Debby; son and daughter-in-law Carol; son Pete; and daughters and sons-in-law Georganne Benesch and David Condon and Elizabeth and Bob Adams, eight grand children and two great grandchildren will also miss their grandfather.
