Termites turn up in Encinitas

We got the following news from Margaret by e-mail. Hi Dad,

The Riel/Mehan household had some unwanted guests that were hard to get rid of. The company went out of business and termites remained active as ever. The ads on the radio and in the paper kept promising "no fuss" x-orange ways of making the house less hospitable to termites. History of waste disposal in SD

Here is a continuation of the Curtis Hartman report we printed in Nov. 2005, Feb 2007, and Mar 2007.

Two months later the City declared the wharf to be unsafe and had to close it. *Ultilissimo* then operated out of a pier at the foot of what is now the Pacific Coast Highway. Prominent businessman J.D. Spreckles owned the pier next to the one used to load *Ultilissimo* with refuse. He complained that the garbage pier was "unsightly" and claimed that the garbage rotting on the pier caused 20 of his workers to get sick. In response to the pressure of Mr. Spreckels, the City proposed that a new refuse collection facility be built at the foot of Hawthorne Street.

The Hawthorne Street proposal appeased Spreckels but left the residents of the area around the proposed collection site furious. Led by Alonzo Horton the residents demanded that the Harbor Commission put a stop to the City's plans. Sensing an opportunity to force the City into doing what the Commissione had wanted all along, the Commissioners passed a resolution ordering the City to move refuse collection to the wharf at the foot of 9th Street. The City refused to comply and the resulting stalemate lasted for a year.
