

LYLE HALL WINS THE RICHARD THOMAS MEMORIAL GRAND PRIZE (TOP ANGLER) IN THE MAKE A WISH FOUNDATION FISHING TRIP



LYLE HALL CATCHES A 50.8 LBS YELLOWFIN TUNA FROM THE "REEL EZE" BOAT to win the top spot in one of the most prestigious tournaments. He beat out 394 anglers who fished on 91 private boats and one charter boat. Of the 394 Anglers, there were 21 lady anglers and 16 junior anglers. Collectively they caught a total of 98 fish: 61 Yellowfin Tuna, 25 Albacore, 6 Bluefin Tuna, 4 Yellowtail (which includes Lyle's whopper), 1 Released Marlin. Lyle's fishing buddy wrote this message suggesting that Lyle is both strong and generous in his victory: "You handled it like a pro! By the way I know you were just trying to be a good host when you offered the fish to me and it had absolutely nothing to do with that burning sensation in your arms. Good job, with that jig it was probably equivalent to a 100lbs fish on a normal jig. You pushed thru the burn and won the battle. Few people will ever catch a fish that big you should be stoked. "

Another notable winner, Meagon Shea, finished in 2nd place (with an albacore that was only .2 from the first place winner Jonathon Baskin). She is mentioned because she was diagnosed with Hodgkin Lymphoma and recently finished her

chemotherapy and is in remission, which allowed her to fish on the family boat Ehukai! Great story of a Make-A-Wish kid triumphant over cancer. The Tuna Challenge volunteers work so hard to make this tournament happen because it raises money for the make a wish foundation helping many children who face the challenges of serious illness.

Lyle won us a \$9000 trip to Alaska by catching the biggest yellow fin tuna this past weekend in the "make a wish" tournament held in San Diego. He made a wish alright and as long as it gets me free travel I am totally onboard. check out the link for the specifics

Francie says "WATCH OUT"

Make sure you register address changes, or suffer these crazy fines
I fortunately will not fine you but would like new address changes for this years family list.
I will be happy to post for you to the RFNL Google site as well. You can kill two birds with one quick toss. --Me.

Francie then forwarded the following information because it suggested that you might have to pay either \$214 or \$178 (#2, & #21) if you did not report a change of address in 10 days. It suggested you better beware - drive carefully and obey all rules as the Sate of California was broke and looking for new sources of revenue. The editors of the RFNL could not agree more that one should drive with care. It also might be reasonable to raise the fines as one has a choice, if you don't want to be charged, don't break the law. But even with this, the amount of fines (in red) did not seem to be consistent with what one thinks is reasonable. So your editors did some checking to see what they could find out about this list. We share the result of our investigations.

The amount of money that one is fined for an offense is determined by all sorts of variable including, time of day (i.e. during rush hour traffic), place of infraction (i.e. near a school, hospital), conditions (i.e. raining, fog) and driving record of the person. That being said, we discovered that there is both a state and country "bail" or starting amount that is used by the courts to determine fines. These were at odds with the rates listed in the message so we have amended the message to include the ones from San Diego. One officer said that higher fees are sometimes used to bring people into court so that they can better understand the problems with their behavior (or get yelled at). The judge has the power to readjust the fine to whatever he or she thinks is fair.

- Failure to obey license provisions \$214
 SD Courts (too many to compare)
- Failure to notify DMV of address change within 10 days \$214 -- S.D. Courts =\$25
- 3. Failure to provide evidence of financial responsibility (insurance) \$796--S.D. Courts =\$200
- 4 . Failure to stop at a red signal. \$436--S.D. Courts =\$100
- 5. Unsafe Speed, 1 to 15 miles over the limit. \$214 -- S.D. Courts =\$35
- Unsafe Speed, 16 to 25 miles over the limit. \$328--S.D. Courts =\$70
- 7. Failure to stop at a stop sign. \$214--S.D. Courts =\$100
- Passing a school bus with flashing red signals. \$616--S.D. Courts =\$150
- Drive using wireless phone not hands free, First offense\$148--S.D. Courts =\$20 subsequent offense. \$256--S.D. Courts =\$50
- Drive while wireless device to send, read or write text. \$148 -- S.D. Courts =\$20
- 11. Minor driver using wireless phone. \$148
- 12. Parking in a bus loading area. \$976
- 13. Violation of disabled parking provisions, first offense. \$976 --S.D. Courts =\$300 second offense. \$1876 --S.D. Courts =\$500
- 14. Unlawful material on vehicle windows. \$178 -- S.D. Courts =\$25
- 15. Adequate muffler required \$178--S.D. Courts =\$25
- 16. Mandatory use of seat belts. \$148--S.D. Courts =\$50
- 17. Mandatory use of child passenger restraints \$436--S.D. Courts =\$100
- 18. Headsets/Earplugs over both ears. \$178--S.D. Courts =\$25
- Motorcycle safety helmet requirements. \$178--S.D.
 Courts =\$25
- 20. No evidence of current registration. \$256--S.D. Courts =\$25
- 21. Notify DMV of change of address within 10 days. \$178--S.D. Courts =\$25
- 22. Display of license plates. \$178 -- S.D. Courts = \$25

The differences are proportional so maybe there is some truth to these assessments but this is the best we can do in terms of fact checking. Best just not to find out by driving within the limits of the law. By the way, if you drive over 100 miles per hour the fine is-\$300 and if you fail to stop give a blind person the right of way--\$500
